## COMPLEMENTARY

Posting a Business Advertisement from a business within or outside of Bon Accord with a valid Bon Accord business licence as defined by the Business Licence Bylaw will be complementary for two (2) weeks per month for the year.

## FEES (subject to GST)

- 1. Additional advertising from a business within Bon Accord with a valid Bon Accord business licence as defined by the Business Licence Bylaw will be at a rate of \$50.00/week or \$100.00/month plus GST, providing no changes are made to the text or graphic of the advertisement.
- Additional advertising from a business outside Bon Accord with a valid Bon Accord Business Licence as defined by the Business License Bylaw will be at a rate of \$100.00/week or \$200.00/month plus GST, providing no changes are made to the text or graphic of the advertisement.
- 3. Any changes to the text and/or graphics of existing advertising that are requested after the business license has been renewed for the year, for a business within or outside of Bon Accord, will incur a fee of \$50. This fee will be charged at the time the form is submitted, as well as each subsequent request submitted.
